Sub: Impementation of the 4-G Project in Rajasthan.


Ref: Minutes of the meeting of the State Level Committee consituted  
under the Chief Secretary for Roll out of 4-G Services issued  
vide No.F.11(2)/SE(Roads)/2015/D-323 dated 07.10.2015

The following decisions were taken in the meeting dated 30.09.2015  
(Minutes were issued by Chief Engineer PWD on 07.10.2015) regarding  
implementation of the 4G clarification given Project in the State of  
Rajasthan:-

1. The matter of checking structural stability of the building where RTT is erected was also raised by Commissioner, Nagar Nigam, Ajmer. Principal Secretary, PWD clarified that after getting Structural Stability Certificate from a qualified Architect/Engineer, there is no need of getting the Structural Stability checked through Nigam Engineers.
2. Commissioner apprised the committee that RTI NOC's are not being issued for the reason that most of the houses in Ajmer are not having building plans approved by the Nigam. The Members felt that this problem is there in almost all the cities. It was, therefore, decided to issue NOC's in such cases after putting up a condition in the NOC that issuance of NOC will neither be presumed as regularisation of the construction nor would create any rights in favour of the owner.
3. The commissioner also apprised that there is widespread resistance from the public on erection of mobile towers. It was explained to him that issuance of NOC & erection of towers are two different issues & there is no role of the nigam in erection of mobile towers. As such issuance of NOC's should not be delayed on this count.
4. It was also brought to the notice of the committee that even after issuance of NOC, the Dy. Commissioner has stopped erection (Site ID:0148) on the ground of public protest which is beyond his jurisdiction. The Pr.Secy.LSG assured that he would speak to the officials at Bikaner & get the things expedited.

You are, therefore, advised to follow the above directions/clarifications while issuing NOC's & during erection of mobile towers.
