Office Order

State Board had issued guideline for abetment of pollution in Brick Kiln units on 17/02/2022 which were kept on hold vide order dated 07/03/2022(copy enclosed) as Ministry of Environment, Forest & Climate Change, New Delhi has issued fresh notification on 22/02/2022 for the siting criteria and environmental standards to be adopted for the Brick kiln units. In continuation of office order dated 07/03/2022 and in reference to MoEF notification dated 22/02/2022, following additional directions are issued to be complied with-

- Brick kiln units may be established on a piece of land duly converted by the revenue authority for the purpose of establishment of brick kiln units, under relevant provisions of Rajasthan Land Revenue (Conversion of agricultural land for non-agricultural purposes in rural areas) Rules, 2007 and subsequent amendment rules, 2016 or on a piece of land allotted by competent authority of State Government for establishment of brick kiln units.
- 2. Brick Kiln units may also be established on Khatedari land for which conversion is not required under Rule 6 of the Rajasthan Land Revenue (Conversion of agricultural land for non-agricultural purposes in rural areas) Rules, 2007 and subsequent amendment.
- 3. All new Brick Kiln units shall submit/obtain distance certificate in the prescribed format(Model format enclosed) issued by the competent authority of State Government not below the rank of Tehsildar as per distance criteria laid down in the MoEF notification dated 22/02/2022.

In view of above, the guideline issued for abatement of pollution for Brick Kiln units dated 17/02/2022 stands withdrawn.
