#### **TERMS & CONDITIONS OF TENDER**

- 1. Tender must be submitted in a properly sealed envelope, according to the directions given in the tender notice.
- 2. Tender form shall be filled with ink or typed. Tender filled in pencil shall not be considered. The tenderers shall sign the tender form at each page and at the end in token of acceptances of all the terms and conditions of the tender.
- 3. The firm should be experience of 3 years in related field in Govt. of Semi Govt. & PSU.
- 4. Rate shall be written both in words and figures. There should not be any error or overwriting. Corrections if any should be made clearly and required to be attested with full signature.
- 5. All rates quoted must be FOR Rajasthan State Pollution Control Board, jaipur and should include all incidental charges.
- 6. The firm shall not assign or sub-let his contract in whole or any substantial part there of to any other agency.
- 7. The RSPCB has reserves the right to accept and tender not necessarily the lowest, reject any tender without assigning any reasons.
- 8. The tender shall furnish following documents at the time of executions of agreement:
  - i. Registration Number and year of registration in case proprietorship firm is registered with Registrar of Firms.
  - ii. Address of residence and office, telephone numbers in case of sole proprietorship.
- iii. Registration issued by the Registrar of companies in case of a company.
- 9. No Advance payment will be made. The charge for maintenance service in payable in four equal installments (25%) on quarterly basis.
- 10. The RSPCB will provide and maintain the electrical installation for providing power supply to the unit.
- 11. Shifting of Air conditioner from one place to another (intra office) have to be covered by this contact.
- 12. Suffering of work will not be allowed work will have to be completed within 24 hrs after the complaint otherwise a penalty of Rs. 300/- per day will be imposed and will be deducted from payment.
- 13. Quantity of above items may increase or decrease by 10% during the AMC period. Charges will be computed on pro data basis, on actual number of items covered under AMC at any point of time.
- 14. Firm should have GST Registration
- 15. GST will be paid extra.

#### 16. CONDITION:-

- i. The Cost of Tender form will be Rs. 500/- and bid security will be 2% of estimated cost of bid. It should be in the form of DD/ Banker Cheque and Bank Guarantee.
- ii. Successful bidder has to submit 5% security deposit amount for the estimated bid value cost.
- iii. Successful tenderer have to submit agreement on stamp paper of Rs.500/-.
- iv. Bidder must be submit bid document Fee and Bid Security with the bid otherwise bid will not be considered.
- v. Bid fee & Bid Security DD must submit in the form of DD / Banker Cheque and Bank Guarantee by the Name of Member Secretary, RSPCB, Jaipur.
- vi. There will be no liability of the State Board if any accident happens.

#### 17. SERVICES:-

- i. Periodical checking and preventive service for the unit four times in a year as evenly spaced as possible.
- ii. Attending the unit when called upon by the Board during normal working hours on all working Days.
- iii. Providing a spare unit as and when required free of charge during repair/overhaul of the unit at approved firm's service station (if not repaired in 48 hrs.)
- iv. In the reference of A.C. supplying free of charge all spares, materials and Gas Refilling & Shifting which are needed for the unit because of wear and tear during the maintenance service contract.
- v. Attending the urgent break down call's not involving spare parts replacement, during normal working hours on Holiday & Sunday except on National Holiday.
- vi. In the reference of A.C. front grill, Knobs, Air filter & Plastic components are not covered by this contract. The Board will have to pay extra charge for the same.
- vii. On completion of AMC period, all A.C. should be in working order.
- viii. Daikin VRV System Indoor Cassette & Hi Wall and Outdoor units service & maintenance and Spare parts are not covered under Annual Maintenance Contract schemes.
- 18. If any dispute arises out of the contract with regard to the interpretation, meaning and breach of the terms of the contract the matter shall be referred by the parties to the Member Secretary, Raj. Pollutions Control Board, Jaipur, who will appoint his senior most officer as the sole arbitrator of the dispute who will not be related to this contract and whose decision shall be final.
- 19. RTPP Act 2012 & RTPP Rule 2013 provision will applicable on the tender or bid.
- 20. If the bidder does not provide satisfactory service the tender can be canceled by the board at any time and the performance security amount will be confiscated.
