## NOTIFICATION

- 1. Short title and commencement. (1) These rules may be called the Rajasthan Municipal (Administrative and Technical) Service (Amendment) Rules, 2025.
- (2) They shall come into force on and from the date of their publication in the Official Gazette.
- 2. Amendment of Schedule. In Schedule appended to the Rajasthan Municipal (Administrative and Technical) Service Rules, 1963, under the head II-Technical Officers, the existing serial number 5 and 5A and entries thereto shall be substituted by the following, namely:-
