## NOTIFICATION

In exercise of the powers conferred by section 337 of the Rajasthan Municipalities Act, 2009 (Act No. 18 of 2009), the State Government hereby makes the following rules further to amend the Rajasthan Municipal (Administrative and Technical) Service Rules, 1963, namely:-

- Short title and commencement.- (1) These rules may be called the Rajasthan Municipal (Administrative and Technical) Service (Amendment) Rules, 2021.
- (2) They shall come into force on and from the date of their publication in the Official Gazette.
- 2. Amendment of rule 8.- After the existing rule 8-E and before the existing rule 9 of the Rajasthan Municipal (Administrative and Technical) Service Rules, 1963, the following new rule 8-F shall be inserted, namely:-
- "8-F. Reservation of vacancies for the ex-servicemen.- (1) Reservation of vacancies for the ex-servicemen shall be 5% in direct recruitment to the posts included in the service.
- (2) Maximum number of such ex-servicemen in a particular cadre shall also be limited to the percentage as specified in sub-rule (1).
- (3) The reservation for ex-servicemen shall be treated as horizontal reservation and it shall be adjusted in the respective category to which the ex-servicemen belongs.
- (4) Where a vacancy reserved for ex-servicemen under sub-rule (1) remains unfilled due to non-availability of suitable ex-servicemen in a particular year, the vacancies so reserved for them shall be filled in accordance with the normal procedure and equal number of vacancies shall be carried forward to the next recruitment year and there after such vacancies would lapse."
