S. No.	Particulars	Amount Payable
1.	Fee of Adjudicator	Rs. 31000/- per dispute for each DAB member.
2.	Travelling expenses	Upto economy class by air /II AC by train / AC taxi by road (on producing original invoices)
3.	Lodging & Boarding	As per prevailing rates of Govt. Circuit House in the concerned city or Rs. 2,500/- per day for hotel.

- 1. The above fee shall be specified in the Dispute Adjudication Agreement.
- 2. The concerned PIU shall ensure provisons of the clasuse 6 of GCC of the contract agreement.
- 3. The above expenses on behalf of employer will be charges under provisional sum of the contract.
- 4. Appointment of the DAB shall be as per clause 20.3 of Section 7 of GCC/PCC.
- 5. The above mentioned fee shall be equally divided between the parties.
