This is without prejudice to the right of the Rajasthan State Pollution Control Board (hereinaker called as 'the Board') to initiate proceeding under the provisions of the Water (Prevention & Control of Pollution) Act, 1974 the reinafter called as 'the Water Act' is

- And whereas, the Water Actionne into force in the whole of the State of Kajazzana with effect from 25.05.1974.
- 2. And whereas, the Water Act to provide for the prevention and control of water pollution and for maintaining and restoring the wholesomeness of water.

And whereas, keeping this in view the Board has been conferred power to take such steps as are deemed necessary for the prevention, control and abatement of water pollution.

- 4. And whereas, Central Ground Water Authority (hereinafter called as 'CGWA) was constituted under sub-section (3) of section 3 of the Environment (Protection) Act, 1986 for the purpose of regulation and control of ground water management and development.
- 5. And whereas, CGWA issued notification on dated 4/1/2017 to obtain NOC for abstraction of ground water.
- 6. And whereas. Hon'ble NGT issued order dated 20/03/2017 in original application no. 158/2016 Naveen Saraswat vs. State of Rajasthan & 3 ors to comply with CGWA notification.
- 7. And whereas, the State Board in order to prevent and control water pollution being caused by the industry and to maintain wholesomeness of water, is competent to issue any directions under section 33 (A) of the Water Act in writing to any person, officer or

"To ensure that all housing colony/Multi story buildings etc. shall have CGWA permission for ground water extraction and a copy of permission submitted to the state board."
