- In view of the significance of this initiative, performance under this activity will also be assessed under the 'Swachh Survekshan-2022, the field assessment of which is scheduled to begin from February 1, 2022. Cities can upload photographs (before and after) of such charuahas/ roundabouts beautification on SBM portal using their login credentials.
- I am sure that your wholehearted cooperation and support will ensure a grand success for this initiative towards celebration of Azadi Ka Amrit Mahotsav by the
