अतः पुनः निर्देशित किया जाता है कि भवन मानियत्र अनुमोदन, प्लीन्थ लेवल तक निर्माण का निरीक्षण व कम्पलीशन सिटिंफिकेट हेतु आवेदन प्राप्त होने पर मौका निरीक्षण हेतु संबंधित मौका निरीक्षक (ऑन सिस्टम द्वारा रेन्डमली चयनित) को पूर्व में विभागीय आदेश दिनांक 27.06.2016 के द्वारा निर्धारित प्रपत्र में ही भरकर 48 घंटो में ऑनलाईन रिपोर्ट प्रस्तुत करनी होगी। मौका रिपोर्ट निर्धारित प्रपत्र में अंकित बिन्दुओं तक ही सीमित होगी। यदि किसी निर्माण के संबंध में कोई शिकायत प्राप्त होती है तो ऐसे प्रकरणों में मौका निरीक्षण हेतु संबंधित नगरीय निकाय के आयुक्त/अधिशाषी अधिकारी द्वारा समिति गठित कर नियमानुसार विधिवत प्रक्रिया निर्धारित की जावेगी।

Under the provisions of Model Rajasthan Bhawan Viniyam, 2013 (For Class 1 Cities excluding Jaipur, Jodhpur & Bhiwadi), Model Sthaniya Nikaya (Nagriya Kshetra) Bhawan Viniyam, 2010, Jaipur Development Authority (Jaipur Region Building) Byelaws, 2010, Jodhpur Development Authority Building Byelaws, 2013 & Greater Bhiwadi Building Byelaws, 2013 for inspection of multistoried buildings order No. F.10(193)UDH/3/2009Part-II dated 11.03.2016 was issued. In supercession of this order for the purpose of site inspection of land prior to approval of building plans and of buildings at various stages of construction such as at plinth level and at the time of issuing completion certificate by different officers shall be adopted as follows:-

- At the time of approval of building plans proposed site shall be inspected jointly 1. by computerized randomly selected Junior Engineer and Patwari/Tehsildar and inspection report shall be submitted online in the prescribed checklist within 48 hours after the inspection.
- 2. Inspection after construction up to plinth level, joint site inspection shall be conducted by the computerized randomly selected officials of Engineering/Town Planning/Revenue wings as per the checklist and inspection report shall be submitted online in the prescribed checklist within 48 hours after the inspection.
- Inspection for issuing completion certificate joint site inspection shall be 3. conducted by the computerized randomly selected officials of Engineering/Town Planning/Revenue wings and also other officer as per requirement from case to case basis, as per the checklist and inspection report shall be submitted online in the prescribed checklist within 48 hours after the inspection.
