No. F.8(Ga)()/Rules/DLB/12/431:- In exercise of the powers conferred by section 337 read with section 43 of the Rajasthan Municipalities Act, 2009 (Act No.18 of 2009), the State Government hereby makes the following amendment in the Rajasthan Municipalities (Payment of Honorarium to Mayor, President and Chairman) Rules, 2010, namely:-

- 1. Short title and commencement. (1) These rules may be called the Rajasthan Municipalities (Payment of Honorarium to Mayor, President and Chairman) (Amendment) Rules, 2015.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- **2. Substitution of rule 2.** The existing rule 2 of the Rajasthan Municipalities (Payment of Honorarium to Mayor, President and Chairman) Rules, 2010 shall be substituted by the following, namely:-
- "2. Monthly allowance.- The Chairperson of a Municipality may receive monthly allowance out of municipal fund, as specified below:-

(i) Chairman of a Municipal Board

Rs. 7,500/- Per Month

(ii) President of Municipal Council

Rs. 12,000 /- Per Month

(iii) Mayor of a Municipal Corporation

Rs. 20,000 /- Per Month"

If any mater not covered by these schedule of powers the same shall be referred to Director Local Bodies with full particular and recommendation for decision.
